#### **TUITION PAYMENTS**

St. Paul's SAC offers an annual one-time payment or a 10-month payment plan. The 10-month payment plan is paid by automatic debit, or check. If paying the 10 month payment plan, payments begin August 16th and ends on May 1st or May 15th. Annual payments are due August 16th and may be paid by check or credit card. August billing is prorated.

#### OVERDUE ACCOUNTS \_\_\_\_\_ Initials

A written notice from the SAC office will be sent to families whose accounts are overdue by one payment. A late fee of \$30 will be applied to all past due accounts. Care services will no longer be provided should an account become past due by one payment. In order to be readmitted, payment must be paid up-to-date including any SAC tuition which became due during the suspension period. All late fees must be paid.

#### LATE PICK UP FEES

School-Age-Care closes at 6:00 p.m. A late pick-up fee of \$1.00 per minute per child with no cap will be charged past 6:00 p.m. Fees are payable directly to SAC or may be billed to your account. Unpaid late pick up fees are considered overdue accounts and will result in discontinued use of the care center

### **DISCIPLINE POLICY**
